## D. Motion on Support for International Students

#### **Council Also Notes**

That international students pay significant fees and do not qualify for grants such as SUSI or the Student Assistance Fund.

#### **Council Regrets**

That this fee is subject to a 3-5% annual increase in Trinity College student fees and this was not reexamined during the COVID19 crisis.

#### **Council Believes**

That international students require more support from the college and believe that the current lines of communication are insufficient. Regardless of EU status, every student needs additional support during the global pandemic.

#### **Council Mandates**

That the Student's Union lobbies against the annual 3-5% increase in student fees, including non-EU students.

#### **Council Further Mandates**

That the President and International Part Time Officer lobbies to ensure the adequate provision of information for international students by the college, including but not limited to the planned methods of teaching for the rest of the year and student support services available.

#### **Council Further Mandates**

That the President also lobbies to ensure that support is made readily available to students by the college on a case-by-case basis when in relation to difficulties regarding travel status to other countries, finances and Government Health guidelines where appropriate. All information should be clearly accessible to students with reference to ever-changing situations and all information should be updated accordingly.

Non-EU students are included in the movement to reduce EU student fees for the

## 1 Béarla

# 1.1 Membership

- Although desirable, the ability to speak Irish is not required to be a member of the committee. Members must be interested in issues surrounding the language in the college and in SU representation.
- Irish Language Officer (Chair, ex-officio)
- President (ex-officio)
- Communications Officer (ex-officio)
- 9 Ordinary Committee Members

## 1.2 Terms of Reference

- 1. The duties of the Coiste na Gaeilge shall be to:
  - a) Discuss and improve on Union policy on the Irish language.

- b) Highlight any issues that individuals may face relating to the Irish language under the SU.
- c) Promote and support SU campaigns relating to the Irish language
- d) Support representation of the Irish language within the SU.
- 2. Meetings of the Coiste na Gaeilge:
  - a) Meetings of the Irish Language committee shall take place at least twice per teaching term.
  - b) The meetings shall be conducted through the Irish language where possible.
- 3. Appointment of the Ordinary Members:
  - a) Any member of the Union may apply to be an ordinary member.
  - b) The format of the application will be decided by the Irish Language Officer.
  - c) Applications will be assessed by the Irish Language Officer.

## 2 Terms of Reference

- 1. The duties of the Welfare & Equality Committee shall be to:
  - a) Assist the in the planning of campaigns relevant to the role of the Welfare Officer.
  - b) Advise the Welfare Officer of any issues faced by members on problems related to the brief of the Welfare Officer, that are causing difficulty to students and to propose solutions to these issues.
- 2. Meetings of the Welfare Committee:
  - a) Shall take place at least three times per academic semester.
  - b) The agenda of the Welfare Committee may include submissions from the members of the Welfare Committee.
- 3. Applications of Committee Members:
  - a) Any member of the Union may apply for any role selected by application.
  - b) The format of the application will be decided by the Welfare & Equality Officer.
  - c) Applications will be assessed by the Welfare & Equality Officer, who will appoint the candidates they believe best suited to each role.

## 3 Review

The Committee shall, on or before January 31st 2021, review its own performance and its terms of reference and shall report its conclusions and recommendations for the campaign going forward to Union Forum.

# TCDSU Diversity in STEM Organising Committee

#### **Terms of Reference**

October 23, 2020

# 1 Purpose

The TCDSU Diversity in STEM campaign shall promote diversity inclusion of gender identity, sexual orientation, race, ethnicity and any other qualities as decided by the Organising Committee.

# 2 Membership

- a) Membership shall consist of:
  - i. Deputy STEM Convenor (ex officio; Chair)
  - ii. STEM Convenor (ex officio; Secretary; non-voting)
  - iii. Four ordinary members, selected by application
- b) The format of the application shall be decided by the STEM Convenor and Deputy STEM Convenor.

- c) Applications will be anonymously assessed by:
  - i. The Deputy STEM Convenor
  - ii. Gender Equality Officer
  - iii. Ethnic Minorities Officer
  - iv. Lesbian, Gay, Bisexual and Trans Rights Officer
  - v. Officer for Students with Disabilities.

# 3 Accountability

- a) Approved minutes shall be submitted to the STEM Faculty Assembly by the Deputy STEM Convenor for discussion.
- b) Draft minutes of the Committee shall be circulated to the Union Forum for noting.
- c) Items, if any, of concern to Union Forum will be returned to the Organising Committee as Matters Arising.
- d) The Chair of the Committee shall be available to report orally to the Union Forum on key aspects of the proceedings of the Committee as required.

# 4 Meetings

- a) Meetings shall be arranged on an ad-hoc basis
- b) There shall be a minimum of two meetings per teaching term
- c) The President shall be invited to every meeting.
- d) The chair may invite other persons to attend meetings for specific agenda items.

# 5 Review

The Committee shall, on or before January 31st 2021, review its own performance and its terms of reference and shall report its conclusions and recommendations for the campaign going forward to Union Forum.
