

Proactive efforts have been made throughout the College year, by various parties, to communicate the current rules and regulations to all residents. Unfortunately, the imposition of fines and possible evictions come as a byproduct of efforts to minimise and disincentivise breaches of the public health guidelines. As with all serious disciplinary cases, we want to assure you that evictions will be taken very seriously and we urge anyone who has been threatened with eviction to reach out to the SU and the JCR. We are concerned about the claims of harshness in disciplinary hearings and we are actively following up with the Warden's team and the Junior Dean to ensure that all student cases are handled fairly. You have a right to fair treatment and fair representation in all College disciplinary meetings and both the SU and JCR are working to ensure that all breaches are handled as such.

The JCR will be hosting a virtual Town Hall meeting via Zoom for residents to voice their concerns on Thursday 4th February at 7PM. We encourage anyone experiencing any issues to attend. TCDSU Sabbatical Officers will also be present to ensure that all issues are addressed or flagged with relevant college authorities.
